- Do seminar again 2 weeks prior to event, during fall/after Christmas, in house black-belt judging class with student involvement (tournament prep)
- School owners need to support set up volunteers, deficiency is that there's set up and tear down (need more help/commitment), target high school students who need volunteer hrs., tournament registration website expand to streaming everything online (tournament, black-belt, volunteering, Awards Banquet and picnic registration), volunteer coordinator?
- Use Clarke Road wrestling mats? "No", not as sturdy and padded as ours
- Day of tournament some black-belts bailed
- Start tournament earlier, people there for 8am rather than 9am
- Noticeable decrease of tension in the room with ring barriers, safety and ring control improved, keep flow (get them in, get them out)
- Reusing first aid Fanshawe paramedic program students

- Got significantly more medals than last year for cheaper/equivalent price, increase medal numbers for next year
- Overall good event, brought in a net profit of approximately \$2,745.00 with a total income of \$8200

# 2017 Annual Picnic

- 80-90 people attended
- Part of increase of income due to \$3 per person, food prices increasing so maintain \$3 flat rate, approx. \$117 profit. Good as picnic is meant to operate as a break even event (some years minor loss, some years minor gain)
- Liz and Roman collaborate organizing 2018 picnic, use \$100-\$200 for picnic seed money
- To prevent people going out of pocket utilize organization credit/debit card (Patrick still looking into it). Accountable cash advances are also possible
- Seikido picnic banner for direction during event
- Brian Johnstone motion to purchase/make FCTKD Banner, seconded by Liz Windover, maybe do World Seikido banner with recognition to FCTKD, Brian and Barry collaborate to look into banner

# 2017 Awards Banquet/2018 Prep

- Patrick Benitez motion to stay with Imperial banquet hall, seconded by Dave Wilkins
- Comments regarding no goodie bags for kids, Leanne Johnstone idea to make piñata for banquet/picnic
- Masters need to approach addressing help from students and parents regarding events
- \$500 from \$1187 to Award Chest, leaving \$600 for subsidy, fundraiser chocolate sale from Sept. Oct., if all schools participate approx. \$5000 profit, very quickly build up subsidy for banquet and outside tournaments, include what proceeds are going to (subsidize sending people to tournaments)
- Dave Wilkins motion to sell chocolates for fundraiser, seconded by Brian Johnstone, unanimously passed

All sites should include price and contact info. Yellow Pages cost is \$498.40 and synced with online search.
- FCTKD website is up and all schools are listed under Master Zeke's mother school, looking to go into Go Daddy, incorporate pg, advertisement through Spectrum. World Seikido FB pg. is separate from FCTKD run by Master Zeke and Alexander (private group), bring friends of friends people who we can trust and build relation with random people off street (need both), FB can be utilized more (everyone has FB, 1 organization pg.). Private groups enable discussions in real time online, Kijiji add is free (broad mention of all clubs with permission)
- Samkomiko toy sale fundraiser, bring it receipts to school head, gets submitted and we get a profit, it's a no pressure sale, capitalize on 10% and get it
- FCTKD crest, Dave Wilkins has digital copy, ordered from overseas, cheap, an utilize again for fundraiser, 200 crests for \$200 USD, can be used as a source of advertisement to show/express who we are

- Rearrange the structure of the banquet, move the dancing and socializing ahead of door prizes--in the past your prize was chosen for you, this improved efficiency
- Leave the little prizes for the picnic, the larger items stay for the banquet.
- Combine the discussion about prizes with the discussion about speeches next meeting
- The show has to move on, ie: you have a time slot and that is your time slot.

### Chocolate Sale:

Profit: \$1500; some chocolates remaining to be sold

### Financials:

- \$5700.50 in Assets, money has already been allocated to various causes
- \$4175 from ticket sales-- the cost of the banquet was \$6348.81

-----Mary accepts position as member (12:56)

- Need to reconsider subsidizations of events loss of \$13 a ticket on the banquet
- Chocolate sale money must be used for tournaments
- Search for other means of fundraising
- Close to \$2500 loss for the Christmas banquet
- Tournament registrations \$8200 -- Tournament expenses \$5500
- This year, have the banquet cost as the actual ticket price? Work on sending more delegates to outside tournaments to promote our own tournaments

- Possible shift banquet from the Imperial to the German Club (German club says they can match any price). Doug Gagel to further investigate for discussion on next meeting.
- Instructors take on some of the subsidization, up to their own discretion

### JLMT:

- On April 27th mats will be picked up
- Looking at picking up a cheaper truck to reduce costs
- People manning the desks need to show up before 9am. By 8am, we need to be ready to go, as people are showing up before the doors open.
- Need about 20 people to volunteer to help with the mats.
  - Creation of a Volunteer director between now and mid-February, if possible; ongoing requirement.
- Setup and take down are the most important parts. Its unfair on the instructors to move all the supplies, need to look at the students to volunteer to move mats. Educate the students that this is for them.
- NEED VOLUNTEERS, NOT VOLUNTOLDS.
- Shirts need to be distributed, Master Gagel first dibs. Shirts that are not sold will be used at future events such as the picnic or banquet.

### Policy and Meeting Change Reminders:

- Harassment Policy with insurance renewal, need all instructors/black belts to sign off on it. This is important part of our insurance requirements. Liability issues could arise if this is not handled annually as required.
- Police Checks:
  - As a volunteer from cost is approximately \$25 for the city of London.
  - Any "Full Instructor" or a supervisor who is there and looking after the class/students
  - This is a volunteer form request and NOT a working with vulnerable persons form.
- Club Dues: 10% at the end of June.

# FCTKD MEETING MINUTES - June 24, 2018

Meeting for Forest City Tae Kwon Do began at 11:05 am at the University of Western Ontario, Health Sciences Building, Room 11.

The financial review was handed out by Patrick Benitez. Items discussed were primarily tournament profit and loss.

# **Post Tournament**

- Registration issues were due to service providers with regards to intake of information. Once these problems are ironed out, the same site can still be used for future use of exchange of information.
- Shortfall of number of Seikido black belts were present/available that were included in a pre -registered list of attendance. Perhaps sending a reminder days before may alleviate absence. Request more Alumni to participate.
- More training is needed for consistent best practises for scoring of points, following tournament rules, and safety guidelines. Reaching out to all alumni to facilitate black belt training seminars would be beneficial.

- Date has been set for the next tournament for May 4, 2019 at Clark Road Secondary school. Dave is awaiting feedback to see if set up could be done on Friday, May 3, 2019 as another event will possibly conflict.

# **Tournament Day**

- Many issues with regards to keeping participants and public out of ring area while participants are competing. Dave Wilkins is looking into pylons and tape to help eliminate crossing into ring areas for subsequent tournaments.
- Darlene Chan raised a concern of having the waiver name, school name, belt ranking as well as birthdate printed so that it would be more legible, but included that pre-registration went really well.

### **Post Picnic**

- Numbers were down this year, perhaps sending out a reminder before the day may be more helpful. Numbers were 50 people this year compared to 80 last year. Total expenses were approximately \$ 320.00. A \$100.00 donation was made by Sutherland Insurance. Expenses were for the cost of pavilion, food, pop, water and piñata. Great games, piñata, soccer, tug of war and water balloons.

# **Annual Banquet**

- Issues brought forward were that gift table taking far too long to get through. It was suggested that only gifts should be given to kids by means of "goodie bags". More discussion is needed to resolve current time constraints.
- Liz Windover proposed age groups 1-3 be selected first going up to older children.
- Bryan Johnstone proposed putting a spot under seat on random selection.

Dave Wilkins motioned to keep a "goodie bag" concept for all children in attendance. Motion carried unanimously and will continue to be discussed at a later date.

It is noted that the perceived "missed" guests was due to a hall error in miscounting the number of chairs per table (i.e. 8 per table were counted instead of 10) thereby having thought enough chairs were put out. However, the

perception is still embarrassing from those attending and best efforts should be made to avoid this. Dave Wilkins suggested to have pre arranged seating plan as this could help in a few ways including reduce day of seating complications and missing chairs from the hall. RSVP has worked out really well. Lori/Patrick are going to look into possibly introducing turkey options from Cuddy farms to the hall to see if they can prepare the turkey as a different options for dinner selections. Patrick expressed a concern about not being able to continue with all of organizing of banquet time constraints, Lori Wilkins elected herself to continue with the planning. The date has been attentively set for banquet on November 24, 2018 and will be confirmed at a later date.

Insurance Policies have been renewed for the year as well as the reviewing and signing of harassment policy by all school owners.

Club dues will include a lump sum and signed review/acknowledge of harassment policy.

More feedback of the task tracker would be appreciated as well as useful for tracking events and responsibilities of who is looking after an item.

Annual return to CRA has been completed up to 2002. The CRA had claimed they had nothing on file, so we may have to re-forward to them.

Forest City Tae Kwon Do has a website, a P.O. Box number, and a telephone number has also been set up. We are hoping to use these tools in the future to set up email for preparation of tournaments including payment options of pay pal and e-transfers of funds.

Justin Charlton has volunteered to design t-shirts for presale only. He is recommended a non-dated version to be sold any time of the year.

The discussion of the Forest City Tae Kwon Do banner was raised. The board would like to see templates of potential designs for future considerations.

### **New Business**

Tournament concerns included revisiting trophy's as well as metals. It was explained that trophies are too expensive with a current fee of \$37.50 for two events and \$2.50 for additional events. The purpose of a low cost for tournaments was at the request of John Lemieux for individuals that couldn't afford to participate.

Bryan and Dave are working on a template to present to potential businesses to promote a sponsoring of the tournaments so that other considerations may become possible.

Ways of additional promotion of the tournament would be through pictures of past tournaments onto the web site.

Feedback from visiting school owners would become vital to any additional ideas, concepts, and food considerations etc. for future upcoming tournaments.

Justin would like to see additional sales of mouth guards, chocolates at the tournament. This was agreed by the board provided that there are available resources and volunteers after first facilitating to meet the primary needs of running the tournament.

Looking into other food options for tournament. Justin is looking into this.

Concerns were brought forward on how to maximize time constraints of the tournament, perhaps age divisions segregated to one ring instead of events occurring at different rings. Dave is going to see how this could be arranged. Attendance has increased by 20 to 50 participants from previous years and continues to grow.

Darlene introduced a different concept of music for the banquet of live music verses a DJ. Will be a future discussion.

Date of next meeting tentatively set for October 7, 2018. TBC.

We are trying to get sanctioned to be in compliance with the criminal code. We reached out to provincial sports groups (Kickboxing, Karate), Karate has been sanctioning some outside groups. # Forest City Tae Kwon Do Annual Meeting Aug 20, 2011

The meeting was chaired by Donna Beauchamp at Mstr Gagels house.

### 1: Previous Meeting:

Minutes of previous meeting read by Bryan Johnstone. Motion to accept M Silverthorn seconded by John Campbell passed.

### 2: FCTKD Relationship with City:

2008 – 2010 400 registrants, \$16492 dollars to fctkd \$9380 kept by city over above 16K. 207 of 400 subsidized to some degree. City is divorcing themselves of promoting programming in Spectrum. At this point City will approve a two year pilot promoting fctkd programming, programs of 8 week duration on a quarterly frequency, where all participant program payments will be given to fctkd entirely BUT students that require partial or full subsidy will need to be drawn from the gross income for that quarter and will not be supported by City Subsidy account. City will promote Seikido program in Spectrum and web. Ross Fair not committed to association w/fctkd, Mayor Fontana onside, mutual association to be reviewed in two years (approx spring 2013). Concern within fctkd would be that at EOC city does not try to assume control of program.

Dave W put to consideration that of the 10% of subsidized school registrant fees paid to fctkd per term half of the 10%, contributed from London Spectrum participants, be set aside into a slush fund to fund subsidized students when nonpaying exceeds paying. Slush fund to be built up to the point where when students ability to pay a minimum course fee needs to be padded from said slush fund, access to slush governed by fctkd treasurer guided by a determined set of fund rules. Future interest in establishing a quality baseline that other non Seikido schools could tag onto Spectrum through fctkd....for discussion.
